After evaluation/scrutiny of Technical Proposal/Bids, procedure for opening of Financial Proposals shall be taken up under the rules. Technical Proposal/Bids submitted after the deadline for submission shall be rejected. Technical Proposal/Bids shall be valid for a period of 180 days from last date of submission.

The Procuring Agency may reject all Bids at any time prior to the acceptance of a Bid as per the Punjab Procurement Rules, 2014.
